


MEMORANDUM OF UNDERSTANDING

FINVERSE UPSKILLING PRIVATE LIMITED ("FINVERSE"), AND

THE TUMKUR UNIVERSITY ("UNIVERSITY), FOR

the implementation of skill development programs for students of commerce and finance by Finverse, across colleges, functioning under the aegis of the University



This MEMORANDUM OF UNDERSTANDING ("MOU") made on this 30<sup>th</sup> day of May 2023, by and between

**FINVERSE UPSKILLING PRIVATE LIMITED**, (formerly known as Edutap Technologies Private Limited) a private limited company incorporated under the Companies Act 2013, having its office at 20 Vishnu Towers, ITI Layout, JP Nagar 1<sup>st</sup> Phase, Bangalore 560078, Karnataka, represented by its Executive Director Mr, Pavan Sharma, and hereinafter referred to as "**Finverse**" (which expression shall unless it be repugnant to the context or meaning thereof be deemed to mean and include their respective successors and assigns) of the FIRST PART  
AND

**THE TUMKUR UNIVERSITY**, a university incorporated under Karnataka State University Act 2000 having its office at Vishwavidyanilaya Karyalaya B.H Road, Tumakuru, Karnataka 572102, India, represented by The Registrar, duly authorized vide Gazette, hereinafter referred to as "**University**" (which expression shall, unless the context otherwise requires, include its successors and permitted assigns) of the SECOND PART

The "Finverse" and "University" are hereinafter referred to as "Party" individually and collectively as "Parties"

**University's Role:**

- 1) Provide infrastructure and other facilities necessary to conduct upskilling programs & recruitment drives
- 2) Encouraging affiliated colleges & students to undertake free app-based upskilling programs offered by Party 2 and such other programs created for their benefit
- 3) Communication with the students regarding upskilling programs, internships & job opportunities and display of advertisement of the same in the college premises.
- 4) Share professional information from the University to Party-2

**Finverse's Role:**

- 1) Provide colleges & students access to its app "Finverse", together with 5 free course credits using which students can upskill themselves.
- 2) Conduct in-person training sessions to upskill students of colleges affiliated to University
- 3) Create job-melas / recruitment drives for the benefit of colleges affiliated to University and their students
- 4) Enable recruitment of the students of the University and its affiliated colleges on their capabilities.
- 5) Share professional information from Party-2 to the University

This Memorandum of Understanding may be amended at any time and it enforce until cancelled with the mutual consent of both the parties.
