Subject: Implementation of 'Central Sector Scheme of Scholarship for College and University Students' through National Scholarship Portal 2.0 for the Academic Year 2017-18.

Sir/Madam,

Department of Higher Education, Ministry of Human Resource Development is implementing the "Central Sector Scheme of Scholarship for College and University Students" since 2008. The scheme is being implemented by the State Education Boards. The Scheme has been brought under the Direct Benefit Transfer (DBT) programme and the scholarship amount is disbursed directly into the bank account of the beneficiaries.

2. Online applications under the scheme are being invited through the National Scholarship Portal (<http://scholarships.gov.in/>) since 2015. For the current Academic year, the process of inviting online application has begun and the last date is 31.10.2017.
3. In the first two years of the National Scholarship Portal, it has been experienced that many institutions had not verified the online applications, thereby making the students in-eligible for the scholarships. To ensure that the students are not deprived of the scholarship for want of verification by the concerned University/Institutions and the State Education Board of your State, you may issue an advisory to them, to verify the online applications of such students on priority basis.
4. Further, the Universities /Institutes and the State Education Board may be requested to give wide publicity about the National Scholarship Portal and the Scheme and also provide hyperlink of the portal on their website.
5. It is also requested that the list of institutions along with the details of nodal officer, telephone number, mobile number and e-mail ID may be provided so that they could be contacted.

Dear Sir,

As you are aware, the "Central Sector Scheme of Scholarship for College and University students" has been brought under Direct Benefit Transfer and the scholarships are being disbursed directly into the bank account of the beneficiaries.

2. The Government has initiated a major reform initiative of disbursing scholarships through the Aadhaar based Direct Benefit Transfer, which entails targeted delivery of benefits through effective use of technology.
3. It is observed that there has been slow progress in implementing the Aadhaar based DBT as only 35% of the disbursement has been Aadhaar based, in the last financial year. The Department has been mandated to ensure 100% Aadhaar seeding of beneficiaries in the scheme by 31<sup>st</sup> December, 2017.
4. You would agree that achieving 100% Aadhaar seeding is possible only if the State Education Boards undertake the enrolment of all students for Aadhaar and seed the same with the bank accounts on a mission mode. Also authentication of Aadhaar and de-duplication of beneficiary database needs to be undertaken to weed out ghost/bogus beneficiaries. This will enable better targeting of programmes, resulting in saving of public funds.
5. You may also like to capture and document best practices in implementation of Aadhaar based disbursement of scholarships through the DBT.
6. An Action Taken Report on the above issues, at the earliest will be appreciated.
