## **REGULATIONS FOR POST-GRADUATE SEMESTER COURSES – 2002**

## Regulation No. 8.5 : CHALLENGE VALUATION

After declaration of the results of the Post- Graduate examination, a candidate who feels that his/her answer script has been valued unfairly can, after remitting a fee of Rs. 1,310/- per script, request the Registrar (Evaluation) for a fresh valuation of his script. The Registrar (Evaluation) may, with the prior permission of the Vice-Chancellor, ask a subject – specialist from among the panel of examiners approved already or specially by the Syndicate, to evaluate the concerned script. The marks awarded in such a challenge valuation shall be overriding the previously – announced one whether or not advantageous to the candidate.

## INSTRUCTIONS

- 1. The Candidate shall apply for Challenge Valuation within **10** (Ten) days from the date of announcement of Results/Marks Card.
- 2. Photo Copy of Result sheet/Marks Card of the concerned examination must be enclosed with the application.
- 3. On receipt of applications of Post-Graduate Challenge Valuation, the concerned Principal of College/Chairman or Chairperson of the Department shall forward the application to the Registrar(Evaluation) within the completion of last date to submit the application (belated applications after completion of last date will not be accepted under any circumstances).
