## आदरणीय महोंदया/महोदय,

To prevent ragging, the UGC has framed regulations on curbing the menace of ragging in higher educational institutions. These regulations are mandatory, and all institutions are required to take necessary steps for its implementation in toto, including the monitoring mechanism as per provisions in the above regulations and ensure its strict compliance. The UGC has also taken several proactive steps, including the effective launch of media campaigns and awareness activities for preventing ragging. Videos on anti-ragging are also uploaded on UGC website for use by higher education institutions.

As a step further, UGC has decided in 2023 that Anti Ragging Day would be observed on 12th August, followed by Anti Ragging Week from 12th August to 18th August. This initiative is one of the tools of the Commission to increase awareness against ragging. The Higher Educational Institutions are desired to adopt the following activities during the celebration of Anti-Ragging

i. Inaugural ceremonies to mark the launch of Anti-Ragging Day/Week.

ii. Competitions such as slogan writing, essay writing, poster making, logo designing, street play performances, photography, quiz competitions, debates, and more on Anti-Ragging themes. Distribute certificates and prizes to encourage the participants to actively promote Anti-

iv. Awareness activities like workshops, seminars, interactive sessions, and other creative avenues such as setting up selfie corners on campus to spread the key messages.
