Applications are invited from eligible candidates for the admission for MBA (Finance) for the academic year 2026-27 offered by Tumkur University.

Eligibility for M.B.A (Finance) Course Admission.

Candidates with any degree obtained from recognized university with 50% of Marks (45% marks aggregate in case of candidate belonging to backward class categories and persons with disability (belonging to Karnataka state only) are eligible to apply for the programme. Admission of the students to the programme shall be as per the University and Government of Karnataka rules notified from time to time. **NOTE:** Rounding off aggregate percent is not permitted.

Eligible Candidates may submit their applications by visiting the Department of MBA Tumkur university Tumkur. The candidates shall pay an application fee **Rs: 500-00 (Rs. 350-00 for (SC/ST/Cat-I)** through SB Collect. The detailed prospectus related to MBA (Finance) admission and the instruction to fill the application can be obtained from MBA department. Filled-in applications(printed) with necessary enclosures should reach "Chairman, Department of Studies and Research in Business Administration" Tumkur University, Tumakuru on or before 25.09.2026, 5.00 pm

Admission for MBA (Finance) will be made through Entrance Examination. Reservation of Seats will be as per the government orders issued from time to time. The merit list will be prepared on the basis of the marks obtained in the Post Graduate Common Entrance Test Conducted by Tumkur University without taking the marks obtained by the candidates in the qualifying examination. The qualifying examination marks is considered only for eligibility.

Omnibus merit list will be published in the University website and also on the notice board of the MBA Department, Candidates are advised to frequently visit University website Chairperson of MBA department to get further information important dates related to academic process.
